- 2.2 A facility Event Package must be completed for all special events and tournaments, and any bookings that would like food preparation/service on site. Please inquire with Sports Field Bookings for more information.
- 2.3 If no members of the group attend the booking, the rental booking will be considered a "no show" for which the rental fee will be non-refundable. Upon receiving three (3) "no shows", the user group will be put on probation by the Allocation Supervisor and may be subject to losing booking privileges.
- 2.4 Motor vehicles are not allowed to drive on parkland, playing surfaces/tracks or adjacent turf, maintenance entrance areas, or inside the facility's fenced area. At no time should a motor vehicle impede or block a maintenance or emergency vehicle access.
- 2.5 Groups cannot access a field during snow removal or while maintenance is taking place.
- 2.6 Access to playing surfaces is provided only at the start of the booked time. Groups may gain entry to the facility 30 minutes prior to rental start time to access dressing rooms. Groups will be permitted 5 minutes past the end of booking to exit the playing field & dugouts (where present) in order for maintenance to commence.
- 2.7 Keys for dressing rooms can be signed out to user groups from Facility Attendants. Dressing rooms are available 30 minutes prior to booking and shall be vacated 30 minutes post booking. Except for dressing rooms, no other keys will be issued to user groups.
- 2.8 Only athletes, players, coaches, officials and trainers are allowed on the field and/or track.
- 2.9 Only teams/participants who belong to the booking group are permitted to use the field area during the booking. Groups are not permitted to use any area of the field for warm-up or cool-down before or after their booking timeslot (e.g., Endzone use)
- 2.10 With the exception of service animals, dogs are not permitted on playing surfaces, the fenced track & field areas, or the bleachers at any time. Dogs are permitted on the green space surrounding the John Fry Park and Goldstick Park playing fields in accordance with the City of Edmonton Parkland Bylaw 2202. Dogs must be leashed at all times and are not allowed onto the playing fields or bleachers at any time.
- 2.11 The consumption of alcohol on City parkland is prohibited.
- 2.12 No food (including sunflower seeds and gum) allowed on the field or track, inside fenced areas, in the scorekeeping booth, or locker rooms.
- 2.13 No smoking, vaping, or chewing tobacco allowed on site (except within designated smoking areas).
